# 1 Introduction

This document is meant for BMW partners from the Nordics region, who want to connect to elnvoicing platform. EDI Guideline is only further clarification of the TEAPPSXML standard. The main objective of the document is to describe the principles of compatibility of documents created based on TEAPPSXML standard with elnvoicing platform. The document highlights the parameters which are necessary in order to properly generate and route TEAPPSXML messages according to elnvoicing platform compatibility requirements. This guideline is valid for TEAPPSXML **version 3.0**.

Below is a glossary of terms:

Dictionary	
Routing	Routing is a process of identifying so called routing parameters in order to determine clearly and definitely relation between document sender and document receiver. Sender, receiver, conformance level and test indicator are input routing parameters. Based on them target format and communication channel are determined, which are output parameters. Each of those parameters can be determined dynamically, based on data contained inside message.
Document incoming	The document sent from partners to BMW
Document outgoing	The document sent from BMW to partners
BMW company code	Code assigned to BMW company by BMW
Partner number	Partner number assigned by BMW
MIG	Message Implementation Guideline
